Australian Customs Service

Refer to the *Preparing for CMR imports* booklet for assistance when completing this form. Customs will initially provide each licensed brokerage with one branch. This may not be sufficient for individual business requirements and this form can be used to establish additional branches.

The following businesses must establish at least one branch themselves:

- Holders of box numbers
- Self-reporting importers who operate under an AQIS Compliance Agreement

Any client may choose to establish a branch, or additional branches, to better manage their dealings with Customs.

A separate *Establishment of branches* form must be completed for each branch required within a business.
