Australian Customs Notice No. 2024/44

Suspension and reduction of preferential rates of customs duty

Reduction of preferential rates - 1 January 2025

On 1 January 2025, preferential rates of customs duty under the following free trade agreements will be reduced:

- India-Australia Economic Cooperation and Trade Agreement (ECTA)
- Regional Comprehensive Economic Partnership Agreement (RCEP)
- Free Trade Agreement between Australia and the United Kingdom of Great Britain and Northern Ireland (A-UKFTA)

Under ECTA, the preferential rates of customs duty for certain iron, steel and aluminium goods will be reduced from 2 per cent to 1 per cent.

Preferential rates of customs duty for certain goods under RCEP, such as certain types of beverages, wood, paper or textile products and other manufactured articles, will be reduced from 5 per cent or 4 per cent to 3 per cent.

Under A-UKFTA, the preferential rates of customs duty for certain cheese and curd products will be reduced to \$0.61 per kilogram and goods of iron and steel will be reduced to 2 per cent.

Suspension of preferential rates – Steel products under the Australia-United Kingdom Free Trade Agreement

Under A-UKFTA, preferential rates of customs duty may be suspended for iron and steel goods where a global safeguard applies to equivalent goods that are exported from Australia and imported into the United Kingdom. At entry into force of the agreement, on 31 May 2023, the United Kingdom had a global safeguard on certain steel products. This safeguard was subsequently extended.

From 31 May 2023, the Customs Tariff (Suspension of Preferential Tariff for Certain UK Originating Goods) Notice 2023 suspended preferential rates of customs duty for certain steel goods classified to 30 tariff headings and subheadings in Chapter 72 of Schedule 3 to the *Customs Tariff Act 1995*. As a result, the goods were subject to a rate of customs duty of 5 per cent. The period for which preferential rates were suspended ended at the end of 30 June 2024 ([Australian Customs Notice No. 2023/21](#) refers). From 31 July 2024, preferential duty rates were reinstated and a 3 per cent rate of customs duty applied to these goods.

From 24 December 2024, the [Customs Tariff \(Suspension of Preferential Tariffs for Certain UK Originating Goods\) Notice 2024](#) suspends the preferential rates of customs duty for steel goods of 74 tariff headings and subheadings in Chapters 72 and 73 in Schedule 3 to the *Customs Tariff Act 1995*. The scope of goods for which preferential rates are suspended has been expanded to align with the list of headings and

subheadings to which the United Kingdom has applied a global safeguard. The goods classified to the headings and subheadings in the notice will be subject to a customs duty rate of 5 per cent until the end of 30 June 2026.

Claiming a refund

Where the 5 per cent rate of customs duty was paid for the goods provided for in Customs Tariff (Suspension of Preferential Tariff for Certain UK Originating Goods) Notice 2023 from the start of 1 July 2024 to the end of 23 December 2024, rather than the 3 per cent duty rate, a refund of customs duty paid may be able to be claimed. Further Information

As the duty rates commencing on 1 January 2025 for Schedules 10A, 14 and 15 are reflected in the Online Tariff and Tariff Working Pages, the pages will not be updated to reflect the new rates.

Goods for which the preferential rates of customs duty are suspended from 24 December 2024 are listed at **Attachment A**. The Online Tariff and Tariff Working Pages will be updated to reflect these changes to Schedule 15. The new Tariff Working Pages are at **Attachment B**.
