OVERVIEW

Under Section 71E of the *Customs Act 1901* approval can be sought from Customs to move goods.

An s71E movement application is made by an owner, or Customs broker acting on behalf of an owner, to move goods entered for home consumption that are subject to Customs control, for the purpose of a Customs examination.

An examination advice must have been generated by Customs for the goods covered by the s71E movement application. Generally, applications for an s71E movement application involve the movement of goods from a Customs establishment (i.e. s15 Wharf, s77G Depot, s77G Container Park, s77G CTO) to the importer's specified premises.

S71E movement applications can be made using the Integrated Cargo System (ICS), either by Electronic Data Interchange (EDI) or Customs Interactive, or by paper document lodged at a Customs office. S71E movement applications can be created directly within the ICS or input by a Customs officer only where there is an electronic import declaration lodged with an associated Exam Advice.

In all instances, s71E movement applications will be evaluated. Permission to move the goods may be granted, subject to conditions, or refused. The granting or refusal of the permission is notified to the owner/broker by the same means by which the application was lodged: either through the ICS or by paper document.

S71E movement applications are approved if the stated premises and its physical attributes are suitable to receive the cargo, and if the movement history of the owner (or broker) is acceptable. If an application is rejected, reasons for the rejection accompany the rejection notice.

Goods that have been moved on an s71E movement application can again be moved for further action (e.g. commerce marking). Any subsequent move requires submission of a new s71E movement application that refers to the original. A movement sequence number identifies this and any further subsequent moves. The ICS limits the number of s71E movement applications that can be submitted for a consignment to five.

There are two types of approvals that can be sought, and these can be submitted in one of two ways:

- Underbond movement request
- S71E movement application

An underbond movement request relates to goods that have not yet been entered for home consumption. If cargo is to be moved, and goods have not yet been entered for home consumption, an electronic underbond movement request must be submitted. Information on underbond movement requests can be found in **Module 6 Import Cargo Reporting** on the Customs website. Go to www.customs.gov.au

An s71E movement application is used for goods that have had an import/warehouse declaration lodged, and the goods have been entered for home consumption. An examination advice must also have been generated by Customs for the goods covered on the s71E movement application.

The same s71E movement application can be used for goods entering Australia on a Carnet. However, because Carnet goods do not have an electronic import declaration lodged, a manual application must be submitted.

This manual only deals with the s71E movement application.

OFFENCES

The *Customs Act 1901* (the Act) contains a range of offence provisions. Many of these offences are specifically described as 'strict liability' offences.

Division 5 of Part XIII of the Act contains an infringement notice scheme that applies to some, but not all, of those strict liability offences. In relation to section 71E applications, the infringement notice scheme applies to subsections 33(2), 33(3) and 33(6).

The infringement notice scheme does not apply to subsections 33(1) and 33(6). Offences under subsections 33(1) and 33(6) require intent to be proven and are prosecuted in court.

Further information on the infringement notice scheme can be located on the Customs website, www.customs.gov.au.

Subsection 33(1) relates to situations where a person intentionally moves, alters or interferes with goods subject to Customs control and that action is unauthorised. The maximum penalty a court can apply to an offence against section 33(1) is 500 penalty units.

Subsection 33(2) relates to situations where a person moves, alters or interferes with goods subject to Customs control and that action is unauthorised. The penalty under the infringement notice scheme for an offence under subsection 33(2) is 12 penalty units. The maximum penalty a court can apply to an offence against subsection 33(2) is 60 penalty units.

Subsection 33(3) relates to situations where an employee of a person moves, alters or interferes with goods subject to Customs control and that action is unauthorised. Subsection 33(4) provides a due diligence defence to subsection 33(3). The penalty under the infringement notice scheme for an offence under subsection 33(3) is 12 penalty units. The maximum penalty a court can apply to an offence against subsection 33(3) is 60 penalty units.

Subsection 33(5) relates to situations where a person intentionally directs or permits another person to move, alter or interfere with goods subject to Customs control and that action is unauthorised. The maximum penalty a court can apply to an offence against subsection 33(5) is 500 penalty units.

Subsection 33(6) relates to situations where a person directs or permits another person to move, alter or interfere with goods subject to Customs control and that action is unauthorised. The penalty under the infringement notice scheme for an offence under subsection 33(3) is 12 penalty units. The maximum penalty a court can apply to an offence against subsection 33(3) is 60 penalty units.

A penalty unit is defined under section 4AA *Crimes Act 1914*.

CREATING A S71E MOVEMENT APPLICATION

The S71E Movement Application Create screen enables users with the appropriate access to create an s71E movement application.

Initially only the Import Declaration ID field displays, and the user must input a valid import declaration number and click the Retrieve Declaration Information hyperlink. Once the associated import declaration data is retrieved, all fields display with the relevant information. The Line Summary Details section is included on the S71E Movement Application Create screen if goods arrive by sea, but not if they arrive by air.



Tip: before attempting to create an s71E movement application, ensure that you have all required information and codes. The following table lists the codes that may be required in lodging an s71E movement application and the fields to which they apply.

| Type of code/identifier | Field name |
|---|-------------------------------|
| An identifier for a broker's branch. | Branch ID. |
| An identifier issued to a broker by Customs. | Nominee Broker Licence No. |
| The identifier of the establishment where the goods originated. | Originating Establishment ID. |

To create an s71E movement application for sea:

Step 1. From the main menu, click on **Imports**, then click on **S71E Movement Application** and then click on **Create Sea**.

The **S71E Movement Application Create** screen displays.

The S71E Movement Application Create screen enables users to create an s71E movement application.

Initially only the Import Declaration ID field displays.

Step 2. In the **Import Declaration ID** field, enter the identifier for the import declaration that is associated with the movement application.

Step 3. Click on the **Retrieve Declaration Information** hyperlink.

Note: if no import declaration with the entered identifier exists, the following message displays, 'No Import Declaration information exists'.

The **S71E Movement Application Create** screen redisplays with information supplied from the entered import declaration.

The Line Summary Details section is included on the S71E Movement Application Create screen if goods arrive by sea but not if they arrive by air.

Step 4. In the **Goods Description** field, enter the free-text description for the goods.

Step 5. In the **Marks and Numbers** field, enter a free-text description including identifying marks and brands on the packages being imported.

Step 6. In the **Reason for Application** field, enter a free-text explanation of why the movement application is necessary.

Step 7. In the **Applicant Name** field, enter the name of the person requesting the movement application.

Step 8. (Optional) Select the **Broker Indicator** checkbox if the applicant is a broker.



Note: the Branch ID field is automatically populated with information retrieved from the import declaration if the Broker Indicator checkbox is selected.

Step 9. (Conditional) In the **Nominee Broker Licence No** field, enter the identifier issued to the broker by Customs.



Note: the Nominee Broker Licence No field is mandatory if the Broker Indicator checkbox is selected.

Step 10. In the **Branch ID** field enter the identifier for the relevant broker's branch.

Step 11. In the **Originating Establishment ID** field, enter the identifier for the establishment from which the goods originate.



Tip: the Originating Establishment ID and Establishment Name fields can be populated using a search. Click on the 'find' hyperlink next to the Establishment Name field and enter the desired value in the search window to initiate the search. On return to the S71E Movement Application Create screen, the fields are populated with the appropriate value.

Step 12. In the **Movement Destination To** field, enter the details of the establishment for which the goods are destined.



Tip: the Movement Destination To field can be populated using a search. Click on the Movement Destination hyperlink and enter the address details or search for an existing address. On return to the S71E Movement Application Create screen, the field is populated with the appropriate value.

Step 13. In the **Seal No** field, enter the seal number of the container provided by the shipping company.

Step 14. (Optional) Select the **Hazardous Goods Indicator** checkbox if the goods are classified as hazardous under Australian or international regulations.

Step 15. (Optional) Select the **Fumigation Indicator** checkbox if the goods have been fumigated prior to entry into Australia.

Note: to remove a line, click on the Remove Line checkbox prior to submitting the document.

Note: to exit the screen without saving, click on the Cancel button.

Step 16. Click on the **Submit** button.

The **S71E Movement Application View** screen displays.

To create an s71E movement application for air:

Step 1. From the main menu, click on **Imports**, then click on **S71E Movement Application**, and then click on **Create Air**.

The **S71E Movement Application Create** screen displays.

The S71E Movement Application Create screen enables users to create an s71E movement application.

Initially only the Import Declaration ID field displays.

Step 2. In the **Import Declaration ID** field, enter the identifier for the import declaration that is associated with the movement application.

Step 3. Click on the **Retrieve Declaration Information** hyperlink.



Note: if no import declaration with the entered identifier exists, the following message displays, 'No Import Declaration information exists'.

Click on the 'find' hyperlink next to the Establishment Name field and enter the desired value in the search window to initiate the search. On return to the S71E Movement Application Create screen, the fields are populated with the appropriate value.

Step 13. In the **Movement Destination To** field, enter the details of the establishment for which the goods are destined.

 **Tip:** the Movement Destination To field can be populated using a search. Click on the Movement Destination hyperlink and enter the address details or search for an existing address. On return to the S71E Movement Application Create screen, the field is populated with the appropriate value.

 **Note:** to exit the screen without saving, click on the Cancel button.

Step 14. Click on the **Submit** button.

SEARCHING FOR A S71E MOVEMENT APPLICATION

The S71E Movement Application Search screen enables users with the appropriate access to search for an s71E movement application in the Integrated Cargo System (ICS).

To search for a s71E movement application:

Step 1. From the main menu, click on **Imports**, click on **S71E Movement Applications**, and then click on **Search**.

The **S71E Movement Application Search** screen displays.

The S71E Movement Application Search screen enables users to search for an s71E movement application in the ICS.

The default search criteria in the Select Combination field are Document Owner Id and S71E Movement ID.

The Document Owner Id field defaults to the ABN or CCID of the company logged into the system. This field is read-only.

Step 2. In the **Select Combination** field, click on the drop-down button and select one of the following options:

- Document Owner and S71E Movement ID
- Document Owner and Import Declaration ID
- Document Owner Examination Advice ID
- Document Owner Importer ABN/CCID and optional Submission Date Range

- Document Owner and Nominee Broker Licence No and optional Submission Date Range
- Document Owner and Branch ID and optional Submission Date Range.

Step 3. Enter the relevant values in the mandatory fields.

 **Note:** the submission date range must be no more than two years into the past and must not include a future date.

 **Tip:** the Importer ABN/CCID and Importer Name fields can be populated using a search. Click on the 'find' hyperlink and enter the name of the desired value in the search window to initiate the search. On return to the S71E Movement Application Search screen, the fields are populated with the appropriate values.

 **Note:** to clear the search criteria entered, click on the Clear button.

Step 4. Click on the **Search** button.

If one record is found, the **S71E Movement Application View** screen displays. Refer to page **21.17**.

If more than one record is found, the **S71E Movement Application List** screen displays.

The View EDI Details, View Evaluation Details and Message Advice(s) hyperlinks display only if data exists.

Line summary details are sorted by container number for sea cargo and by master air waybill number for air cargo.

The S71E Movement Application Subsequent Move(s) Create screen enables users to create a subsequent s71E movement application.

Step 7. In the **Reason for Application** field, enter a free-text explanation of why the movement application is necessary.

Step 8. In the **Marks and Numbers** field, enter a free-text description including identifying marks and brands on the packages being imported.

Step 9. In the **Movement Destination (To)** field, enter the details of the establishment for which the goods are destined.



Tip: the Movement Destination (To) field can be populated using a search. Click on the Movement Destination hyperlink and enter the desired value in the search window to search, add or edit the destination details. On return to the S71E Movement Application Create screen, the field is populated with the appropriate value.

If the goods arrive by air, refer to **Step 14**.

Step 10. (Optional) In the **Seal No** field, enter the seal number on the original container or other identifier as a consequence of the subsequent move (eg, Customs seal number).

Step 12. (Optional) Select the **Hazardous Goods Indicator** checkbox if the goods are classified as hazardous under Australian or international regulations.

Step 13. (Optional) Select the **Fumigation Indicator** checkbox if the goods have been fumigated prior to entry into Australia.


The S71E Movement Application View screen enables users with the appropriate access to withdraw a previously entered s71E movement application.

To withdraw an s71E movement application:

Step 1. Ensure the S71E Movement Application View screen is displayed.

Step 2. Click on the **Withdraw** button.

The **Withdrawal Details Add** screen displays.



Step 3. In the Withdrawal Reason field, enter the details relating to why this movement application is being withdrawn.

Step 4. Click on the **Submit** button.



Note: clicking Submit on this screen is an acknowledgement that the authority to deal with the goods will be withdrawn, as stated on the screen.
