INTENTION TO REVOKE TARIFF CONCESSION ORDER

It is intended to revoke the Tariff Concession Order for the goods described in the following TABLE.

The Comptroller-General of Customs' delegate has declared the intention, subject to s.269SD(1AB) of the Customs Act 1901, to make an order revoking the TCO in the table below with effect from 31 March 2021.

On 30 March 2021, the Comptroller-General of Customs' delegate formed the belief in respect of the TCO, that if the TCO was not in force on that day, and an application for the TCO was made on that day, the Comptroller-General of Customs would not have made the TCO.
